ENEMO is an international network of 22 leading non-profit, non-partisan and civil society organizations from 18 countries of Central and Eastern Europe and Central Asia, including three European Union countries, founded in 2001, as an informal international network. Over the years, the network continued developing and evolving and has been especially progressing in recent years. It's development culminated when the Ministry of Public Administration in Montenegro made a decision on April 11th to formally register ENEMO in the Register of Non-Governmental Associations.

ENEMO registered in Montenegro is the only ENEMO ever registered with the actual Constitutional Protocol. It is functioning fully in accordance with its Constitutional Protocol and the national legal system of Montenegro.

ENEMO seeks to promote civil society involvement towards improvement of electoral processes, greater transparency of the governments and their accountability to the citizens, and respect of basic human rights and freedoms. To achieve this aim, ENEMO works independently or in cooperation with its member organizations.

The main field of ENEMO expertise is carrying out professional and impartial international election observation. ENEMO supports promotion of democracy in its region of engagement

by deploying international election observation missions to assess the electoral processes and political environment, and to offer accurate and impartial observation a reports, along with prospective solutions and creative approaches to the identified problems.

**ENEMO** observation missions 11Se international benchmarks and standards for democratic elections and the host country's legal framework to evaluate the electoral process. ENEMO is capable of deploying missions of various scale in accordance to proven and reliable methodology. ENEMO and all of its member organizations have endorsed the 2005 Declaration of Principles for International Election Observation and the Declaration of Global Principles for Non-partisan Election Observation and Monitoring by Citizen Organizations. Each ENEMO observer signs the Code of Conduct for International Election Observers.

ENEMO aims to improve electoral processes in ENEMO region and to stipulate exchange of experiences and best practices in elections monitoring field within ENEMO member organizations. The organization strives to boost transparency and accountability along with respect of basic human rights and freedoms in ENEMO region in the field of promotion of human rights and basic freedoms and securing transparency and accountability of the governments.

### DIVERSITY OF MEMBER ORGANIZATIONS

ENEMO member organizations are from different regions and countries and have know-how and experience in elections and different spheres of engagement beyond elections topics. ENEMO Governing board is the main governing body of the Network comprising five member organizations elected for two-year term through General Assembly. All member organizations are summoned once a year to conduct the General Assembly with the aim to discuss important issues related to the work of ENEMO.

#### **EXPERTISE**

ENEMO member organizations engage a wide pool of individuals that are broadly recognized as election and civil society experts, both on a country level and internationally. Zlatko Vujovic, President of the Governing Board of CeMI and ENEMO's Executive Director and Olga Aivazovska, Head of the Board of the Civil Network OPORA are members of the Board of Directors of the Global Network of Domestic Elections Monitors (GNDEM), GNDEM is the only global association of election monitoring organizations that gathers 251 member organizations from 89 countries and territories, and regional network members in Africa, Asia, Europe and Eurasia, Latin America and the Caribbean, and the Middle East/North Africa.

#### STRUCTURE AND GOVERNANCE

ENEMO Governing board is the main governing body of the Network comprising five member organizations elected for twoyear term through General Assembly. All member organizations are summoned once a year to conduct the General Assembly with the aim to discuss important issues related to the work of ENEMO. ENEMO's legal representative is Zlatko Vujovic, the Executive Director.
